We recently hired a consultant from CDS (Cooperative Development Services Co-op) to conduct a staff survey to see how our Co-op is measuring up as a workplace. The results were excellent! This summary of the report couldn't make me happier –


"...This data suggests that, Willimantic Food Co-op employees are much more satisfied than staff at other co-ops around the country in the majority of the areas studied in this survey..." No resting on our laurels though, there is still work to do, but this shows that the effort we have put into our workplace is effective, and staff, for the most part, are happy.

I never stop marveling at the breadth of tasks that managing the Co-op requires. We are a little food store in an old Mill Town...how hard can that be? But many days I go home with my mind reeling. It is part of what has kept me at this job so long. I am never bored and I am constantly learning new things.

# **Annual Meeting of the Willimantic Food Co-op**

**Date:** Sunday, April 22, 2018 5:00pm - 7:45pm

**Location:** Windham Theatre Guild Burton Leavitt Theater, 779 Main St, Willimantic, **CT** *A vote of the membership on proposed changes to the by-laws will take place at the annual meeting.* 

### **Explanation of Proposed 2018 Willimantic Food Co-op By-laws Changes**

Changes are proposed to the bylaws primarily to ensure members will legally be able to vote "in absentia" (versus being required to attend a meeting in person) on issues, and to make clearer the steps required for members to request a Special Meeting or to add an issue to the agenda for a member vote at a general meeting.

Additional changes are to align with State law the rights of the members to elect and remove Directors; to make the by-laws consistent with the Co-op's "policy governance" model of oversight; and to update the by-laws by removing paper- and postal-service-based requirements for documentation and communication.

Shown below is the text of the by-laws now in effect in the left column, and the text with the proposed changes in the right column. Only sections with proposed changes are shown here.

Full texts of the existing by-laws as approved April 2016, of the proposed by-laws incorporating the revisions, and of the proposed by-laws in "markup" format are available on the Willimantic Food Co-op web site from links on the page at: https://www.willimanticfood.coop/about-the-co-op/our-board/ (Willimantic Food Co-op > About the Co-op > Board), and on the Board bulletin board at the Co-op.

### WILLIMANTIC FOOD CO-OP, INC. BY-LAWS Adopted April 16, 2016

### Section 2.2: Rights

**Article II: Membership** 

Each member shall be entitled to make purchases from the Co-op on terms generally available to members, to participate in the governance of the Co-op as set forth in these by-laws and to receive a copy of these by-laws. Members may also contribute labor or service to the operational needs of the Co-op and thereby be entitled to receive discounts on their purchases. All issues involving major policies, fundamental changes and financial rights and interests of members must be decided or approved by members.

### WILLIMANTIC FOOD CO-OP, INC. BY-LAWS Revisions Proposed Spring 2018

In Article 1: Organization, Section 1.1: Purposes, the word "Co-op" is revised to capitalize all occurrences.

### **Article II: Membership**

### **Section 2.2: Rights**

Each member shall be entitled to make purchases from the Co-op on terms generally available to members, to participate in the governance of the Co-op as set forth in these by-laws including election of member-owners to the Co-op's Board of Directors; to participate in member benefit programs as established by the Board and management; and to receive a copy of these by-laws. Members may also contribute labor or service to the operational needs of the Co-op and thereby be entitled to receive discounts on their purchases. All issues involving the fundamental purpose and structure of the Co-op and financial rights and interests of members must be approved by members. Reference in these by-laws to the rights and entitlements of members, other than the right to redemption of capital funds, shall be understood to refer only to members in good standing ("active" members).

### **Section 2.3: Inactive Status**

A member who becomes delinquent by three months in meeting his or her capital payment obligation, or who fails to keep the Co-op advised of his or her current address as evidenced by two mailings having been returned by the post office as undeliverable, shall be placed into inactive status. A member in inactive status may attain active status upon resuming regular payments and paying a reinstatement fee, if any, as determined by the Board or by resuming communication with the Co-op and providing correct contact information. Reference in these by-laws to the rights and entitlements of members, other than the right to redemption of capital funds, shall be understood to refer only to active members.

### **Article III: Meetings of Members**

### **Section 3.2: Special Meetings**

Special meetings of members may be called by the Board or by the President. A special meeting shall be called within fifteen days of receipt of petitions signed by at least five percent of all members which state any proper business to be brought before the meeting.

### Section 3.3: Notice

Written notice of the time and place of any meeting of members, together with a statement of the purposes of such meeting, shall be given to each member not less than ten nor more than fifty days before the date of the meeting. At a special meeting of members, no other business than that stated in the notice shall be transacted.

### Section 3.4: Quorum and Voting

The presence of twenty-five members shall be necessary and sufficient to constitute a quorum for the transaction of business at any meeting of members. Each member shall have one vote on each matter submitted to a vote of members. Proxy voting shall not be permitted. Unless

### **Section 2.3: Responsibilities**

Member-owners shall keep current in equity investments due to the Co-op, shall keep the Co-op informed of any changes in name or current contact information, and shall abide by these bylaws and the policies and decisions of the Co-op and the Board. A member-owner who upholds these responsibilities is considered an active member.

### **Section 2.4: Inactive Status**

A member who becomes delinquent by three months in meeting his or her capital payment obligation, or who fails to keep the Co-op advised of current contact information as evidenced by two communications having been returned as undeliverable, shall be placed into inactive status. Inactive members may not be notified of meetings of members nor participate in member votes, but retain their right to redemption of capital pursuant to Article VII. A member in inactive status may attain active status upon meeting the responsibilities of membership, including resuming regular payments and paying a reinstatement fee, if any, as determined by the Board or by resuming communication with the Co-op and providing correct contact information.

*Note:* Sections 2.3-2.6 are renumbered as 2.4 - 2.7 due to the insertion of "Responsibilities" as 2.3 above.

### **Article III: Meetings of Members**

### **Section 3.2: Special Meetings**

Special meetings of members may be called by the Board or by the President. Members may request that a special meeting be called by submitting a written petition stating the business to be brought before the members and signed by at least five percent of active members. Notice of the special meeting shall be issued within fifteen days of receipt of the petition by the Board. The special meeting will be held no less than two months after receipt of the petition. No business shall be conducted at a special meeting except that specified in the petition and notice of the meeting.

### **Section 3.3: Notice**

Notice of the time, place and purpose of any meeting of members shall be posted in a conspicuous place at the Co-op and communicated to member-owners not less than ten nor more than fifty days before the date of the meeting.

### Section 3.4: Quorum

The presence of twenty-five members shall be necessary and sufficient to constitute a quorum for the transaction of business at any meeting of members. The Board is authorized to reduce the number required for a quorum if a quorum is not attained at two successive meetings of

otherwise required by law or by these by-laws, issues shall be decided by two-thirds majority vote or, in the case of the election of directors or where two or more options are presented on a single issue, by plurality vote. Meetings of members shall be conducted in conformity with generally-accepted rules of parliamentary procedure.

### Section 3.5: Balloting by Mail

The Board of Directors may authorize balloting by mail in conjunction with a meeting of members through procedures that are designed to assure fairness of the process, secrecy of ballots, and convenience to members. In such event, the notice of the meeting shall include a ballot and a full description of the issue to be voted upon. Ballots shall be returned either by mail or in person at the store during the month proceeding the date of a meeting of members. Submission of such a ballot shall be equivalent to presence in person at a meeting of members with respect to the issue covered by the ballot, and votes cast by ballot shall be counted together with votes cast in person at the meeting.

### **Article IV: Board of Directors**

### **Section 4.1: Powers and Duties**

Except as to matters reserved to members by law or by these by-laws, the business and affairs of the Co-op shall be directed and controlled in the interests of members by the Board of Directors (sometimes referred to in these by-laws as "the Board"). The powers and duties of the Board shall include, but not be limited to, engaging the general manager and monitoring and evaluating his or her performance, overseeing the operations of the Co-op, approving budgets and fiscal controls (in accordance with policy governance), securing good conditions of employment and assuring that the purposes of the Co-op are properly carried out.

### **Section 4.7: Termination**

The term of office of a director may be terminated prior to its expiration in any of the following ways: (1) voluntarily by a director upon notice to the Co-op; (2) automatically upon termination of membership in the Co-op or upon termination of employment in the case of management and staff directors; and (3) involuntarily, with or without cause, by the members entitled to vote for the election of such person or, in the case of a director appointed by the Board, by the Board, provided in either case that removal is at a meeting the notice for which states that the purpose, or one of the purposes, of the meeting is to remove the director. A Director who fails to attend three consecutive Board Meetings, unless excused by the Board, shall be requested to resign.

members, to ensure that the Co-op is not prevented from conducting business.

*Note:* provisions in prior 3.5 "Balloting by Mail" are covered by proposed 3.4 "Quorum" and 3.5 "Voting."

### **Section 3.5: Voting**

Each active member shall have one vote on each matter submitted to a vote of members. Voting in person at a meeting shall be accomplished through procedures established by the Board assuring fairness of the process, secrecy of ballots and convenience to members. The members may vote at a meeting without attending in person by authorizing a proxy to cast that member's vote; provided, however, that any proxy authorization is valid only if the authorization directs the proxy to vote in a prescribed manner on each question. Voting by proxy shall be equivalent to presence in person at a meeting of members. Unless otherwise required by law or by these by-laws, issues shall be decided by two-thirds majority vote or, in the case of the election of directors by plurality vote.

### **Article IV: Board of Directors**

### Section 4.1: Powers and Duties

Except as to matters reserved to members by law or by these by-laws, the business and affairs of the Co-op shall be directed and controlled in the interests of members by the Board of Directors (sometimes referred to in these by-laws as "the Board"). The powers and duties of the Board shall include, but not be limited to, establishing policies for guidance of the Co-op, overseeing the operations of the Co-op by engaging the general manager and monitoring and evaluating his or her performance, and assuring that the purposes of the Co-op are properly carried out, in accordance with its Policy Governance manual.

### **Section 4.7: Termination**

The term of office of a director may be terminated prior to its expiration in any of the following ways: (1) voluntarily by a director upon notice to the Co-op; (2) automatically upon termination of membership in the Co-op or upon termination of employment in the case of management and staff directors; and (3) involuntarily, with or without cause, by the members entitled to vote for the election of such person, provided in either case that removal is at a meeting the notice for which states that a purpose of the meeting is to remove the director.

### **Section 4.8: Vacancies**

Any vacancy among directors occurring between regularly scheduled times for election of directors shall be filled for the balance of the unexpired term by the Board in the case of consumer director positions, by management members in the case of the management director, and by non-managerial staff members in the case of the staff director position.

### **Article V: Meetings of the Board**

### **Section 5.2: Notice**

Meetings called by the Board shall require no further notice than the decision of the Board. All other meetings shall require notice to all directors. Written or electronic notice shall be delivered not less than ten days before the date of the meeting and oral notices in person or by telephone shall be given not less than three days before the date of the meeting. Notices of meeting of the Board shall also be posted in a timely manner and in a conspicuous place at the principal office of the Co-op, but failure to do so shall not affect the validity of the meeting.

### Section 5.5: Action Without a Meeting

Any action required or permitted to be taken at a meeting of the Board of Directors may be taken without a meeting if a written consent to the action is signed by all directors and filed with the minutes of meetings.

### **Article VI: Officers**

### **Section 6.1: Designation**

The officers of the Co-op shall consist of President, Vice president, Treasurer, Secretary, and such other officers or assistant officers as may be determined by the Board. The President, Vice President and Secretary shall be chosen from among directors.

### Article VIII: By-laws

### **Section 8.2: Amendment**

These by-laws may be amended or replaced only at an annual or special meeting of members, provided that the proposed amendments are stated or fully described in the notice of the meeting at which the amendments are to be adopted.

### **Section 4.8: Vacancies**

Any vacancy among directors occurring between regularly scheduled times for election of directors may be filled for the balance of the period remaining until the next opportunity for a vote of members by the Board in the case of consumer director positions; and for the balance of the term by management members in the case of the management director, and by non-managerial staff members in the case of the staff director position.

### **Article V: Meetings of the Board**

### **Section 5.2: Notice**

Regular meetings called by the Board shall require no further notice than the decision of the Board. Special meetings shall require notice to all directors. Written or electronic notice shall be delivered not less than ten days before the date of the meeting, or oral notices in person or by telephone shall be given not less than three days before the date of the meeting. Notices of meeting of the Board shall also be posted in a timely manner and in a conspicuous place at the principal office of the Co-op, but failure to do so shall not affect the validity of the meeting.

### Section 5.5: Action Without a Meeting

Any action required or permitted to be taken at a meeting of the Board of Directors may be taken without a meeting if a written consent to the action is signed by all directors and filed with or recorded in the minutes of meetings.

### **Article VI: Officers**

### **Section 6.1: Designation**

The officers of the Co-op shall consist of President, Vice president, Treasurer, Secretary, and such other officers or assistant officers as may be determined by the Board. The President, Vice President and Secretary shall be chosen from among the directors.

### **Article VIII: By-laws**

### **Section 8.2: Amendment**

These by-laws may be amended or replaced only by a vote of members, provided that the proposed amendments are stated or fully described in the notice of the meeting at which the amendments are to be adopted.

### Winky's Food Review Winky Gordon

As the world careens along – chronic violence here and around the world, insanely early spring, increasing economic divide, for starters- I am reminded of the bumper sticker: "Where are we going? And why am I in this handbasket." Yes, the world is in an uproar. So what's a girl to count on, what can help recalibrate? Wholesome food that is nutritious and satisfying is one place I turn when I need to feel my feet on the earth. Thank the Goddess for good food.

Need grounding and sustenance? Organic chickpeas and lentils are about as basic as you can get - unelaborate food of the earth, packed with nutrition. Chickapea Pasta (\$4.29/8 oz. package) is among the category of not-beautiful but delicious foods and it packs a 27-gram protein punch with each serving. It really is made with just the flours of organic chickpeas and red lentils, nothing else. It cooks up just like regular pasta and can be eaten with your favorite sauce or....just to be daring I ate it plain. I repeat: it's not pretty. But it's darn good all by itself, with a nutty flavor coming through. I can imagine eating this with tahini, not exactly a conventional pasta topping but one that would enhance the nutty factor. And it would visually blend in with the pasta, yielding an overall boring brown. Remember, beauty is in the taste buds of the beholder. In case it matters to you: it's organic, gluten-free, kosher, vegan, non-GMO verified, and has a low-glycemic index. Ta dah.

Maya Kaimal's Butter Masala (\$5.49/12.5 oz. jar) is not so much grounding as it is warming and cheering. Who couldn't use that right about now? Bon Appetit says this about the line of Maya Kaimal curry sauces, "Slightly spicy and very complex, this curry in a jar tastes as satisfying as home cooked." The butter masala contains tomato puree, buttermilk, half-and-half, butter, "spices," and lemon juice among other things. It is neither low fat nor low sodium! The taste that comes forward first for me is the lemon, giving it a pleasant tang among the richness of all those dairy products. But it also contains cilantro - tangy itself- and fenugreek leaves. I first ate this over rice, which was fine but not especially interesting. Today I covered tofu with the sauce and baked it, giving it a more robust opportunity to shine. Tofu is such a great foil for whatever it's cooked in and, believe it or not, the bland tofu texture contrasted well with the strong taste of the curry, tomatoes, lemon and so on. We carry several other Maya Kaimal curries. Pay attention – while this sauce was mild, the others vary in their heat ratings.

YumEarth brings us good old-fashioned black licorice that is organic, gluten, soy, egg and dairy free,

and made in a peanut-free facility (\$3.99/5 oz. bag). And it actually tastes like – surprise!- licorice. Its organic ingredients include: rice flour, brown rice syrup, cane sugar molasses, cornstarch, andlicorice extract. I dig the sharp taste of this licorice, a flavor that I don't eat or drink often enough. I'm not quite as keen on the texture. It's a little denser



than I might like – it takes a bit to get to chewy. This has not stopped me, however, from happily munching on this candy by the handful. My completely unscientific review of its medicinal properties demonstrates that licorice may well be the corrective herb of this moment in time. It is purported to be an anti-inflammatory, blood cleanser, liver detoxifier, and to provide adrenal support. It is soothing and healing. Could I have that IV please?

Finally, just for fun, because fun itself can be balancing and restorative, I bring you feel good foods' vegetable potstickers (\$6.99/10 oz. package). Not organic, but vegan and gluten free, these little puppies would make a great appetizer or adjunct to a fuller meal. They're basically just vegetables – cabbage, onion, carrots, shitake mushrooms – in a rice pasta pocket. By themselves they're pretty mild with a hint of ginger; it's the dipping sauce that gives them zip. It contains tamari (which they don't state is gluten free...hmmm), sugar, white vinegar, ginger, garlic, black pepper. I went the lazy way and followed directions for microwave cooking and they were just fine. Yes, I'd eat them again. And any food you can eat with your fingers, whether you're supposed to or not, gets extra points from me.

That's it for me for this time. Meet you in the aisles at the Co-op as we weather these strange times together. Eat good food. Thank the earth under your feet. And be kind – to yourselves and to one another.
