

#### From the Board President

I admit I don't know where to begin. The year had so many "do overs" and new beginnings, fresh starts and "we've never done this before" moments. While the struggles were real, there is much we can celebrate and be proud of. I'll start with a thank you to the 400 new members who joined the Willimantic Food Co-op in the midst of a pandemic. Whether it be about a solution in a moment or the beginning of a long relationship, thank you for seeing the Willimantic Food Co-op as a community resource. And then a

thank you to the 7000+ existing members who purchased over half a million dollars in product from local producers, keeping our local economy going. And of course, there is no bigger thank you than the one that goes to the staff. 37 dedicated people who figured it out, kept us safe, kept each other safe, got us our food, created new systems, supported other co-ops, and did it with good cheer (and lots of pizza).

During this pandemic year, despite the occasional sensation of drinking from a fire hose, things got done. The Board Executive Council and the Coop's management team met weekly, providing support in both directions. This, along with regular monthly Board meetings, meant that the ongoing operational and governance needs of the Co-op continued. The Board also met monthly with our Columinate consultant Todd Wallace, who helped us to maintain calm, gave us a broader perspective, and advised us during the pandemic. We

actually had a retreat in October! Todd Zoomed in for the morning session and then we met outside in the afternoon. Board members also attended training, met in subcommittees, and logged hours in webinars.

To finish with gusto! The Board attended peer-to-peer dialogs, JEDI training (Justice, Equity, Diversity and Inclusion) and attended one national conference and one regional conference, virtually. We also put out an RFP to support member engagement work that was a direct result of our retreat in October. I even managed to take a walk with Danny Spear, the Board President from Fiddleheads, just to check in. I don't want to repeat this past year. At the same time, it is nice to know that we are capable of drinking from that fire hose.

The Willimantic Food Cooperative strives to provide its members, shoppers and the greater community a retail food store which:


- Supports and increases sustainable agriculture, locally, regionally and globally, with a strong emphasis on local and regional agriculture and food processing.

### **Treasurer's Report**

The Co-op ended 2020 well financially, but we could not have predicted that outcome in early 2020. Covid19 created uncertainty for all of us including the Co-op. Would we be able to remain open? How would we keep staff and members safe? Would the supply chain break down? How would we keep supporting local farmers? Would we be able to meet member needs? These are just a few of the questions as the pandemic took hold and sales dropped significantly. This uncertainty led the Co-op to pursue a Payroll Protection Program loan for \$243,440 to ensure the Co-op could safely continue its role as an essential service, a vital employer, and a good steward of members' investment even as sales dropped and expenses increased.

In response to the pandemic, Co-op management took a different approach to meeting member needs by going completely curbside. Although this maintained a safe environment and met many of our members' needs, it soon became apparent that the system had to be improved, and Webcart was developed. Building these new business models while working through the pandemic was not in the 2020 plan, but the Co-op's amazing staff went above and beyond and DID IT! All staff were kept on payroll and received hazard pay during the pandemic. The Co-op was also able to continue support of local organizations whose needs deepened. The Co-op donated \$25,941 to local organizations in addition to \$35,000 in charitable donations made by individual members.

At the end of 2020, the co-op satisfied all the requirements of the PPP loan and the proceeds became income. This resulted in strong 2020 net income and positions the Co-op to face more uncertainty in 2021. While performance is improving, sales continue below pre-pandemic levels and pandemic expenses continue, but management expects 2021 performance to be closer to break even.

The Co-op's 2020 performance is remarkable. Thanks to staff and management, the Co-op navigated the pandemic thus far with the capacity to remain strong and continue to serve members and the community.


